Environmental Fate and Distribution

Air: This product liquid which has a very low vapour pressure (<1 mm Hq). As a result it is unlikely

to become an atmospheric contaminant unless generated as an aerosol.

Water: This product has a very low water solubility (< 100 ppb). As it has a specific gravity of < 1, if

> discharged to water, it will initially form a surface film. As the product is non volatile and has a high binding affinity for particulate matter, it will adsorb to particulates and sediment out.
